**SPECIFIC COLLABORATION AGREEMENT UNIVERSITY OF GUADALAJARA**

**AND GUJARAT VIDYAPITH**

On the one hand, Dr. Marco Antonio Cortés Guardado, General Rector of the University of Guadalajara and legal representative of the same (hereinafter UdeG) as provided in Article 32 of the Organic Law, residing at number 975 Avenida Juárez , Zona Centro, CP 44100 in Guadalajara, Jalisco, Mexico.

Moreover, Dr. Sudarshan Iyengar, Vice Chancellor of the Gujarat Vidyapith (hereinafter GV) in accordance with the provision made in the constitution under Clause 4(2) 8 residing at Gujarat Vidyapith, Ashram Road, Ahmedabad 380014.

**STATEMENTS**

1. Both entities have signed a general agreement of academic cooperation, scientific and cultural, under which this specific collaboration agreement on the exchange of academic staff is signed.
2. The GV and the University of Guadalajara with an interest in promoting the Gandhian philosophy in Latin America through the Spanish translation of an unpublished work of Mahatma Gandhi (founder of the University) with the intent to be edit and promote in Spanish-speaking countries.
3. The GV and the University of Guadalajara aims to create a joint Center for Latin American Studies for the dissemination of culture, politics, and the economy of this region as well as teaching the Spanish language.
4. The GV and the University of Guadalajara promote the training of academic staff in graduate programs.

**CLAUSES**

**FIRST.** The purpose of this agreement is to establish the basis and criteria on which the University of Guadalajara and exchange programs run by GV academic staff.

**SECOND.** To operate the exchange program of academic staff will take effect on the following basis:

1. The exchange of academic staff will require approval of both institutions.
2. Academic staff will receive their salary from the home institution during their stay at the host institution.

3. The host institution will provide accommodation for visiting professors for the duration of stay, up to a maximum of three years.
4. Academic staff's involvement in the receiving institution would be to promote inter-institutional relationship.
5. The work programs implemented and carried out must be accepted by both institutions, according to the interests of those expressed in this agreement.
6. Both institutions agree to exchange relevant bibliographic and audiovisual material that facilitates the achievement of this agreement.

**THIRD.** The parties state that the signing of this agreement and the commitments made in it are the product of good faith, so take all the necessary actions to comply therewith, in case of any discrepancy in interpretation, this will be resolved by mutual agreement.

Read this instrument, the parties aware of the content and scope of each of its clauses and indicating that there is no celebration in fraud, bad faith, or any other reason that vitiate consent, is signed in duplicate, in Spanish.
